Petitions for determination of Cross Subsidy Surcharge and Additional Surcharge for FY 2016-17 under Sections 38, 39, 40 & 42 (2) of the Electricity Act, 2003

Sri P. Shiva Rao, learned Standing Counsel for the petitioners, Sri K. Gopal Choudary, learned counsel representing (i) ITC Ltd., Chirala (ii) M/s. Sree Rayalaseema Green Energy Ltd., (iii) Biomass Energy Developers Association (iv) M/s. RPP Ltd., & (v) M/s. Espar Pak Ltd., Sri R. Shiv Kumar representing The Federation of Telangana and Andhra Pradesh Chambers of Commerce and Industry (FTAPCCI), Sri Sandeep Kumar Bairoliya and Sri M.S.S. Sarma, representing A.P. Ferro Alloys Producers Association and Sri M. Venugopala Rao, Senior Journalist are present and Sri S. Suryaprakasa Rao and M/s. Synergies Castings Limited, Objectors are not present.

Heard Sri K. Gopal Choudary, learned counsel representing (i) ITC Ltd., Chirala (ii) M/s. Sree Rayalaseema Green Energy Ltd., (iii) Biomass Energy Developers Association (iv) M/s. RPP Ltd., & (v) M/s. Espar Pak Ltd., Sri R. Shiv Kumar representing The Federation of Telangana and Andhra Pradesh Chambers of Commerce and Industry (FTAPCCI), Sri Sandeep Kumar Bairoliya and Sri M.S.S. Sarma, representing A.P. Ferro Alloys Producers Association and Sri M. Venugopala Rao, Senior Journalist on their objections. The petitions for determination of Cross Subsidy Surcharge had admittedly been filed based on the data projected in the ARR of the petitioners. But, in the meanwhile, an order determining the tariff for Retail Supply for FY 2016-17 having been made, only such data as has been accepted by the Commission to form the basis for such tariff can form a reasonable basis for estimation of Cross Subsidy Surcharge. Sri P. Shiva Rao, learned Standing Counsel for the petitioners is requested to have the claims of the petitioners for fixation of Cross Subsidy Surcharge filed in accordance with the Tariff Order data. Sri K. Gopal Choudary and other objectors also submitted that some of the required data has not been furnished while the authenticity and accuracy of some data furnished appears doubtful and discrepant. Sri P. Shiva Rao, learned Standing Counsel is requested to have the data already furnished by the petitioners in their responses duly verified and to place before the Commission with copies served on the objectors the true and correct data already furnished and to be furnished. The revised calculation of Cross Subsidy Surcharge based on the Tariff Order shall also be furnished in its copies to the objectors. Posted at request to 25-06-2016.
