In terms of section 87 (1) of the Electricity Act, 2003 read with Regulation No.2 of 2004, the State Commission may, by notification establish with effect from such date as it may specify in such notification, a Committee to be known as the State Advisory Committee.

 Accordingly, the following notification will be published in the Ex-ordinary issue of Andhra Pradesh Gazette.

NOTIFICATION

In exercise of the powers conferred by section 87 of the Electricity Act, 2003 [Act No.36 of 2003] and the Andhra Pradesh Electricity Regulatory Commission (Constitution of State Advisory Committee and its functioning) Regulation, 2004 {Regulation No.2 of 2004}, the Andhra Pradesh Electricity Regulatory Commission hereby constitutes the State Advisory Committee (SAC) as specified in the Annexure.

- 2. The functions of the SAC shall be as detailed in Section 88 of the Electricity Act, 2003 read with the Regulation No.2 of 2004.
- 3. The tenure of the members of the said Committee shall be for a period of 3 (three) years with effect from 24-01-2015.
