## ABSTRACT

Extension of Exemption issued in Order No.46 dated 15-06-2004 in respect of Rural Electric Co-Operative Societies.

ORDER:

In terms of section 13 of the Electricity Act 2003, the Commission in Exemption Order No.46 dated 15-06-2004, issued exemption to the following four RURAL ELECTRIC CO-OPERATIVE SOCIETIES from the application of section 12 of the Electricity Act 2003 for the period of one year from 09-06-2004 to 08-06-2005. The Exemption was based on the recommendation of the State Government of Andhra Pradesh vide their letter No.90/Pr.II(2)/2000-13 Dt. 05-06-2004.

- 2) Subsequently, the Exemption Order No.46 dated 15-06-2004 was renewed upto 31-03-2013.
- 3) The above four RESCOs have filed applications in the prescribed formats seeking extension of exemption granted earlier from the application of section 12 of the Electricity Act 2003 for further periods beyond 31-03-2013. The applicants filed all the relevant documents and also paid application fee of Rs.30,000/- as per Clause 4 of Regulation No.1 of 2005.
- 4) Whereas, after due consideration, the Commission is of the view that it is in the public interest and as per the recommendation of the Government of Andhra Pradesh, to grant the further extension of the exemption granted earlier.
- Accordingly, in exercise of the powers under Section 13 of the Electricity Act, 2003, the Commission is pleased to extend the exemption granted by Order No.46 Dt.15-06-2004 to the Co-operative Societies namely, (1) The Anakapalli Rural Electric Co-operative Society Ltd., (2) The Cheepurupalli Rural Electric Co-operative Society Ltd., (3) The Siricilla Rural Electric Co-operative Society Ltd., and (4) The Kuppam Rural Electric Co-operative Society Ltd., from the application of provisions of Section 12 of the Electricity Act, 2003 for a further period of one year from 01-04-2013 to 31-03-2014 subject to and on the same terms, conditions and restrictions contained in the licences (except that the words 'licence fee' should be read as 'exemption fee') earlier granted to them under the provisions of the Andhra Pradesh Electricity Reforms Act, 1998.
