Note:

1. The morning session, 10.30 AM/11.00 AM to 1.00 PM/1.30 PM, will be in-person, and the afternoon session, 2.00/2.30 PM to 4.30 PM, will be via video conference. However, these timings will be modified, if necessary, by the Commission depending on public participation each day.
2. The objectors mentioned above shall wait for their turn. In case the hearings are completed before the scheduled time, the objectors scheduled to present their views on the following day will be heard, subject to their readiness. If any member/members does/do not get their turn on the scheduled day before the stipulated timings for hearings, they will be heard on priority on the following day.
3. If any request is received from other than the objectors mentioned above for a hearing, after all the persons scheduled to speak for the day are heard, depending on the availability of time, such persons may make their submissions, with the permission of the Commission.
4. All objectors/stakeholders are advised to confine their submissions to the ARR, FPT & CSS filings, present their views briefly, and not repeat views already presented. Further, objectors/stakeholders need not repeat the written views already submitted, except to highlight the key points. Each objector/stakeholder will be provided a maximum of 10 minutes during the public hearings to present his/her views, unless extended by the Hon'ble Chairman at his discretion. The views on the filings of the three DISCOMS will be heard together. Each objector will be given a chance only once over the four days of the public hearing.
5. The public hearings on all four days (20.01.2026, 22.01.2026, 23.01.2026 and 27.01.2026) will be streamed live and can be watched by anyone. The DISCOMS will publish the live link through various communication channels.
