This Original Petition having come up for hearing in the presence of Sri Challa Gunaranjan, learned Counsel for the petitioner and Sri. G. V. Brahmananda Rao representing Sri P. Shiva Rao, learned Standing Counsel for the respondent, and upon hearing the arguments of both the Counsel, the Commission passed the following :

ORDER:

This Original Petition is filed for the following substantive relief :

“..... to clarify and/or exempt the petitioner company from the Renewable Power Purchase Obligation (RPPO) and that the energy consumed from its 9.5 MW WHRS plant through co-generation process is to be considered for setting off the petitioner’s RPPO requirement qua its consumption from other conventional sources under the Regulation No.1

of 2017, in view of the consumption of power from its co-generation WHRS unit through waste heat received from flue gases and to pass such other order/s in the facts and circumstances of the case as this Hon'ble Commission may deem just and equitable in favour of the petitioner.”

At the hearing, Sri Challa Gunaranjan, learned Counsel for the petitioner submitted that the issue raised in this O.P. is squarely covered by order dated 25-11-2020 in O.P.No.44 of 2020 of this Commission. Sri G.V. Brahmananda Rao, learned Counsel representing Sri P. Shiva Rao, learned Standing Counsel for the respondent, has not disputed this submission.

In the light of the above, following the aforementioned order in O.P.No.44 of 2020, this O.P. is allowed as prayed for.
