## <u>Detailed guidelines for ensuring public participation through video</u> conference

- 1. Persons who are desirous of being heard through video conference shall inform the same in advance to APGENCO with a copy to the Commission indicating the date and name of the office of the Executive Engineer/Divisional Engineer(Operation) of the DISCOMs from which they intend to present their views/objections/suggestions.
- 2. APGENCO shall have to serially number all such requests received by it with a date and time stamp.
- 3. APGENCO shall compile all such requests received and send the same to the Commission.
- 4. The Commission, after duly taking into account other exigencies, if any, will host on its website, the list of the persons who have registered to present their views with details such as the S.No., Name, Date & name of the office of EE/DE(Operation). A copy of the same list will be communicated to the respective DISCOM and APGENCO.
- 5. On receipt of the list, APGENCO in coordination with DISCOMs shall make necessary arrangements for the persons to present their views/objections/suggestions on the day of the public hearing.
- The Executive Engineer of the APGENCO shall be present at the office of the 6. DE/EE of DISCOM concerned. If any office of the DE/EE concerned receives requests from persons who have not earlier communicated their intent to make their submissions in person on the hearing day, the DE/EE concerned shall inform the same to the Commission through video conference on that date of hearing, after all the registered persons are heard. If the Commission permits, such persons may make their submissions. Further, APGENCO in coordination with DISCOMs shall provide a meeting link and publish it in public newspapers to enable the general to present their views/objections/suggestions video through conference from their homes/offices without the necessity of going to the DE/EE's office.
