These Original Petitions have come up for final hearing on 20-07-2022 in the presence of Sri A.P. Reddy, learned counsel for the petitioners; and Sri P. Shiva Rao, learned

Standing counsel for the respondents, and upon carefully considering the material available on record and after hearing the arguments of the learned counsel for both parties, the Commission passed the following:

COMMON ORDER

In these batch of O.Ps., the only prayer is to direct the respondents to pay the bills to the petitioners for the energy received by the respondents as fixed in the respective PPAs upto the expiry of the ten years.

Mr. P.Shiva Rao, learned Standing Counsel for the respondents, has submitted a tabular sheet showing the details of payments made to each of the petitioners. He also orally submitted that there are no outstanding payments due to the petitioners upto the expiry of the ten years period and that separate petitions for fixing the tariffs from the 11th year onwards are filed by the petitioners and the same are pending.

Sri A.P. Reddy, learned counsel for the petitioners, has not disputed the above submission. Inasmuch as the payment, as claimed by the petitioners, upto the expiry of the ten years period, at the rate of PPAs, is stated to have been made, no further adjudication of the O.Ps., is necessary.

The O.Ps., are accordingly disposed of.
