This Original Petition has come up for hearing before us today in the presence of Sri P.Shiva Rao, learned counsel for the petitioner; Sri Deepak Chowdary, learned counsel for respondents 9 and 10 and also representing Sri K.Gopal Chowdary, learned counsel for the Respondents Nos.8 & 18; Sri Anand Hitesh, learned counsel for respondents No.2; Ms. Altaf Fathima, learned counsel for Respondent No.17 and Smt G.Malathi, learned counsel for Respondent No.11; that none having appeared for respondents 1, 3 to 7 and 12 to 16; and that after hearing the learned counsel for the parties and on consideration of the material on record, the Commission passed the following:

**ORDER**

This Original Petition is filed for the following reliefs:

- a) To direct the Respondents to pay the transmission charges of total amount of Rs.43,10,66,740/- on the basis of the invoices raised by the Petitioners as per the APERC Tariff Orders and Regulations, along with interest from 2004 onwards. or
- b) Pass such other order or orders as this Hon'ble Commission may be pleased to pass in the interest of justice.

During the hearing it is brought to the notice of this Commission by Sri P.Shiva Rao that the consumers of respondent No.17 have filed a Writ Petition before the Honourable High Court of Andhra Pradesh questioning the

action of the petitioners, which is also impugned in this OP. He further submitted that while three of the respondents have already made payments; in respect of other respondents, the petitioners are proposing to revise the demands.

Inasmuch as the issues raised in this OP are the subject matter of the Writ Petition before the Honourable High Court and also the fact that the petitioners are seeking to revise the demands, it is not appropriate to decide this OP, on merits, at this stage.

Accordingly, the OP is closed, however, with liberty to the petitioners to avail a fresh remedy if their claims against the respondents survive even after disposal of the Writ Petition and also after revision of the demands.
