This Original Petition has come up today for final hearing in the presence of Sri Challa Gunaranjan, learned Counsel for the Petitioner; and Sri P.Shiva Rao, learned Standing Counsel for the respondents, that

after hearing the learned counsel for both the parties and after carefully considering the material available on record, this Commission made the following:

**ORDER**

This Original petition has been filed under Section 142 of the Electricity Act, 2003 (for short "the Act") to punish the respondents for non-compliance/violation of Clause 3.2.2.1 of the General Terms and Conditions of Supply of Distribution and Retail Supply Licences in Andhra Pradesh.

At the hearing, it is submitted by the learned counsel for both the parties that post-filing of this petition, the Voltage Surcharge levied on the petitioner has been withdrawn and the amounts recovered from the petitioner have been adjusted in the future bills.

Sri Challa Gunaranjan, learned counsel for the petitioner, submitted that the grievance of the petitioner stood fully redressed with the above subsequent action of the respondents.

In the light of the above, the petition is closed.
