This Original Petition has come up for hearing before us today in the presence of Sri Deepak Chowdary, counsel representing Sri Challa Gunaranjan, learned counsel for the petitioner, Sri P. Shiva Rao, learned Standing Counsel for the respondents, that after carefully considering the material available on record and after hearing the arguments of the learned counsel for both parties, the Commission passed the following:

### **ORDER**

This Original Petition is filed for the following reliefs:

"i) to exempt the petitioner company from the Renewable Power Purchase Obligation (RPPO) and that the energy consumed from its

WHRS plant through co-generation process is to be considered for setting off the petitioner's RPPO requirement qua its consumption from other conventional sources, under the Regulation No.5 of 2022, in view of its consumption of power from its co-generation WHRS unit through waste heat received from flue gases from the date of commissioning of the WHRS plant i.e. 08.03.2022; and

(ii) to pass any such other order or orders as this Hon'ble Commission deems fit and proper in the interest of justice".

At the hearing, the learned counsel for both the parties fairly admitted that the issue raised in this OP is squarely covered in favour of the petitioner by several orders, including the one in OP No.11 of 2020 dated 07-9-2020 (Ultratech Cement Ltd. Vs. A.P.State Load Despatch Centre, Hyderabad).

In the light of the above, this OP is allowed in terms of the relief granted in O.P.No.11 of 2020.
