These Original Petitions along with IAs have come up hearing before us today in the presence of Sri A.P. Reddy, learned counsel for the petitioners and Sri P. Shiva Rao, learned Standing Counsel for respondents, that after carefully considering the material available on record and after hearing the arguments of the learned counsel for both parties, the Commission passed the following:

COMMON ORDER

The main grievance of the petitioners in this batch of OPs., is that the respondents have not been discharging their obligation of prompt payment for the power received by them from the petitioners.

Pending the OPs., the Commission has given direction to the respondents to pay the admitted arrears of tariff as per the approved PPAs upto 31-3-2020 on or before 15-7-2021.

Sri P. Shiva Rao, learned Standing Counsel for respondents, placed before the Commission a Tabulated Statement, wherein it has been, *inter alia*, stated that as per the directions of this Commission respondent No.2 has cleared the entire dues to all the petitioners on 15-7-2021 upto the period mentioned in Column-F; and for the subsequent periods as shown in Column-H; and payments are being made under the LPS scheme in instalments.

Sri A.P.Reddy, learned counsel for the petitioners, submitted that he is yet to receive instructions on the payments claimed to have been made by respondent No.2. At the hearing, Sri P. Shiva Rao, learned Standing Counsel for respondents, submitted that the above statement was prepared in consultation with the Officers of respondent No.2; and that after due confirmation of the payments only he has been confirming the factum of payment of the said amounts.

In the light of the above, we have no reason to doubt the veracity of the Tabular Statement furnished to the Commission and the oral submissions made by the learned Standing Counsel for the respondents.

As the payments, as per the prayers in the Original Petitions, are claimed to have been made, the substantial grievance of the petitioners stood redressed.

As regards the prayer for payment of LPS, the Government of India has come out with a Scheme in this regard. Hopefully both the parties may settle this dispute even in respect of the periods anterior to the period which is covered by Gol

Scheme. Therefore, we are not inclined to adjudicate the said dispute at this stage. However, the petitioners are left free to avail a fresh remedy either in case the statement in respect of payments made by respondent is found incorrect and/or the dispute regarding the LPS is not amicably settled.

Subject to the above, the OPs., are disposed of.
