This Original Petition has come up for hearing today in the presence of Sri P. Shiva Rao, learned Standing Counsel for respondents 2 and 3; that none having appeared on behalf of the petitioner and respondent No.1; and that after carefully considering the material available on record and after hearing the arguments of the learned Standing Counsel for respondents 2 and 3, the Commission passed the following:

ORDER

This O.P. is filed for the following relief:

- “ i) to direct the 1st respondent to fix RoW land damages compensation @ 250% with interest to the petitioners land within 30 Days as the matter is pending for over 5 years;
- ii) to direct 2nd respondent APTRANSCO to pay compensation within 30 days of issuing proceedings by the 1st respondent Collector; and
- iii) to pass any other order as the Commission deems fit and proper” .

We have heard Sri P.Shiva Rao, learned Standing Counsel for respondents 2 and 3. None appeared for the petitioner and respondent No.1.

As far the prayer in the petition, viz., for grant of compensation at 2½ times more than the market value in respect of the RoW land, Sri P.Shiva Rao, learned Standing Counsel for respondents 2 and 3, fairly conceded that this aspect is covered by the detailed order dated 21-9-2021 passed by this Commission in Revision Petition No.1 of 2020 and batch (***R.Ramamurty Naidu Vs. Collector & District Magistrate, SSR Nellore District***).

Though respondent No.2 in its counter has raised an objection relating to limitation, it is not disputed by Sri P.Shiva Rao, learned Standing Counsel for

respondents 2 and 3, that the Apex Court categorically held that the period of limitation during the Covid period shall be excluded for the purpose of computing limitation. This Ratio of the Apex Court binds every authority in the country since it is the Law of the Land.

In the light of the above, the OP is allowed in terms of the order dated 21-9-2021 passed in Revision Petition No.1 of 2020 and batch. Accordingly, the prayer to the extent of RoW compensation at 2.½ times more than the land value is allowed. Respondent No.1 shall pay the differential compensation within two months from today.
