This Original Petition has come up for hearing before us today in the presence of Sri Tanuj Chauhan, counsel, representing Sri Adarsh Tripathi,

learned counsel for the Petitioner; and Sri P.Shiva Rao, learned Standing Counsel for the respondents ; that after hearing the learned counsel for both parties, and that after carefully considering the material available on record the Commission passed the following:

**ORDER**

This O.P. is filed for the following reliefs :

- a. Direct the Respondent No. 1 to pay Rs.1,85,37,600 as per the agreed terms of the LOIs issued in favor of the Petitioner in terms of the banking arrangement between the Petitioner and the Respondent No.1;
- b. Take appropriate actions against the Respondent No.1 for flouting regulations 18 and 19 of the CERC (Open Access in inter-State Transmission) Regulations, 2008 ;
- c. Pass any other or further orders as this Commission may deem fit and proper in facts and circumstances of the present case.

At the hearing, learned counsel for the petitioner has placed before the Commission, a letter addressed by the petitioner to the General Manager (Finance), APPCC, wherein, it is stated that following reconciliation between the parties, the petitioner is agreeing for receiving late payment surcharge of Rs.1,22,97,121/-. The Learned Counsel for the petitioner submitted that a specific time frame may be fixed for the respondent to make the payment of aforementioned money. Sri P. Siva Rao requested reasonable time for making such payments. Two months time is accordingly granted for payment with the rider that no further time will be allowed for whatsoever reason. Subject to above ,the O.P. is disposed.
