NOTIFICATION

In exercise of the powers conferred under sub-section (1) of Section-4 of the Andhra Pradesh Electricity Reforms Act, 1998 (Act.No.30 of 1998) read with section 85 (1) of the Electricity Act, 2003 (Act 36 of 2003), the Government of Andhra Pradesh hereby constitute a Selection Committee with the following, for selection of persons for appointment of Member of the Andhra Pradesh Electricity Regulatory Commission:

3. The Selection Committee shall finalize the panel of two suitable persons for the post of Member in the Commission as per the provisions of the A.P. Electricity Reforms Act, 1998, the Electricity Act, 2003 and as per the provisions contained in G.O.Ms.No.35, Energy (Power-III) Dept., Dt.01.08.2014 and also as per the A.P. Electricity Regulatory Commission (Appointment of Chairman & Members) Rules, 1999 and shall submit to the

Government the said panel along with the details and information prescribed under sub-section (3) of Section -5 of the A.P. Electricity Reforms Act, 1998.
