**NOTIFICATION**

In exercise of the powers conferred by Section 87 of the Electricity Act, 2003(Central Act No.36 of 2003) and the Andhra Pradesh Electricity Regulatory Commission(Constitution of State Advisory Committee and its Functioning) Regulation 2004 (Regulation No.2 of 2004), the Andhra Pradesh Electricity Regulatory Commission hereby constitutes the State Advisory Committee (SAC) with 18

members as specified in Annexure with **Sri Thakur Rama Singh**, Member/Chairman (i/c) of APERC, as the **ex-officio Chairman**, and **Sri P.V.R. Reddy**, Member of APERC, as an **ex-officio Member** of SAC.
