Shiva Rao, learned Standing Counsel for the respondents are present. After carefully considering the material available on record and after hearing the arguments of both parties, the Commission passed the following:

ORDER

Sri Anand K Ganesan, learned counsel for the petitioner and Sri P. Shiva Rao, learned counsel for respondent Nos.1 to 3 are heard. Both the learned counsel brought to the notice that in O.P.No.19 of 2014, this Commission has already passed orders not accepting the request of the distribution companies for being exempted from the Renewable Power Purchase Obligations. This petition in effect and substance is to enforce the said RPP obligations against obligated entities and the learned

counsel for the petitioner therefore submitted that if Discoms comply with their obligation under Regulation No.1 of 2012, there is no further need for passing any order or giving any direction in this petition. The Discoms being public entities can hopefully be expected to comply with their prescribed obligations as expeditiously as possible. Sri P. Shiva Rao, learned Standing Counsel for the Discoms has reported in O.P.No.19 of 2014 that they are in a position to comply with the said obligation shortly, which they will do. In view of the said assurance, there is no need for any specific directions herein and this petition is consequently closed, as it is no longer necessary in view of the orders in O.P.No.19 of 2014. No costs.
