The petition has come up for hearing finally on 31-07-2015 in the presence of Sri R. Yella Reddy, learned counsel for the petitioner, Sri S.V.S. Choudary, learned counsel for the implead petitioners (M/s. Axis Wind Energy Ltd & others) and Sri P. Shiva Rao, learned Standing Counsel for the 3<sup>rd</sup> respondent are present. After carefully considering the material available on record and after hearing the arguments of all the learned counsel, the Commission passed the following:

#### **ORDER**

Sri R. Yella Reddy, learned counsel for the petitioner, Sri S.V.S. Choudary, learned counsel for the implead petitioners (M/s. Axis Wind Energy Ltd & others) and Sri P. Shiva Rao, learned Standing Counsel for the 3<sup>rd</sup> respondent are present. The only prayer in the main petition is for either issuing necessary directions or frame necessary tariff regulations for procurement of wind energy by distribution licensees based on the relevant CERC regulations. The implead petitioners also wished to be brought on record, to be heard on merits regarding the relief sought for by the main petitioner. However, regulation for fixation of tariff for the financial years 2015-16 to 2019-20 for wind projects to be established in the State of Andhra Pradesh and to be commencing their operation since such regulations coming into force are being made to come into effect since their publication in the A.P. Gazette and hence, nothing further remains to be granted in the present petition. If the petitioner or the implead petitioners are aggrieved by any of the contents of the regulation that is being made, it is always open to them to take recourse to any remedies available to them under law in this regard. Subject to the said observation, these proceedings and the petition are hence closed, no costs.
