Sub:- Procurement of power from M/s LANCO & M/s Spectrum during FY2020-21 on short term basis-Conditional approval accorded for April and May 2020-Revision of Tariff-Reg.

Vide the reference (1) cited, APDISCOMS have requested the Commission to permit them to procure power from M/s LANCO & M/s Spectrum power plants during FY2020-21 on short term basis till such time the expected gas diversion to the State run GGPP plant materializes or the Gas Supply Agreement expires, whichever is earlier, or until the review petition filed on the Tariff Order for FY2020-21 is disposed of. Accordingly, the Commission, inter alia, has approved the proposal of the DISCOMs temporarily at single part tariff of Rs.3.29/Unit (kWh) and Rs.3.31 /Unit (kWh) from M/s LANCO & M/s Spectrum power plants respectively

with certain conditions for the months of April and May 2020 vide the reference 2 cited.

Now DISCOMs vide the reference 3rd cited, have requested the Commission for downward revision of procurement tariff at Rs.2.69/Unit (kWh) and Rs.2.71 /Unit (kWh) from M/s LANCO & M/s Spectrum power plants respectively in view of the reduction of domestic gas prices from USD 3.23/MMBTU to 2.39/MMBTU by MoPNG ,GoI, for the period 1st April to 30th September 2020.

Therefore, Order dated 27.03.2020 is modified by substituting the Tariff per unit, at the rate of Rs.2.69/unit for M/s LANCO and Rs.2.71/unit for M/s Spectrum in place of rates mentioned in the Commission's order Dt 27.03.2020 (Reference 2). The remaining part of the order dt.27.03.2020 shall stand in all respects.
