Ltd. has filed Appeal No.278 of 2024 before the Honourable APTEL challenging the Common Order dated 19-4-2024 passed by this Commission in OP Nos.1 to 16 and 22 to 26 of 2019; and whereas the Honourable APTEL, while setting aside the Common Order dated 19-4-2024 passed by this Commission in the said OPs., remanded the matter to this Commission for reconsideration in the light of the Judgment of the Honourable Supreme Court in Tata Power Company Limited Transmission vs. Maharashtra Electricity Regulatory Commission & Others (2022 SCC OnLine SC 1615).
