This Original Petition has come up for hearing before us today in the
presence of Sri G. Venkateswarulu, counsel representing Sri N.Sai Phanindra
Kumar, Learned Counsel for the Petitioner; Sri G.V.Brahmananda Rao,

Counsel representing Sri P.Shiva Rao, Learned Standing Counsel for the Petitioners are present at the hearing; that after hearing the learned counsel for both parties, and that after carefully considering the material available on record the Commission passed the following:

ORDER

This original petition is filed for the following relief :

- a. Approve the termination of the Power Purchase Agreement (PPA) dated.10.07.2013 entered into with the Respondent by the Petitioner; And
- b. Direct the respondents 1 and 2 to permit the petitioner to avail Open Access through Long Term Open Access (LTOA) for withdrawal of power from its 0.8 MW Wind Power Plant situated at S.y.No.628 of Mustikovilla Village, C. C Palli Mandal, Nallakonda Area, Ananthapuram District, Andhra Pradesh for consumption at petitioner's plant situated at Gooty Road, B.Kotliapalli, Ananthapur, A.P-51573;
- c. Pass any such other order/s in the facts and circumstances of the case as this Hon'ble Commission may deem just and equitable in favour of the Petitioner.

At the hearing, the learned counsel for the Petitioner submitted that the Petitioner has filed a memo before the Hon'ble Commission seeking withdrawal of the main petition.

Sri G.V. Brahmananda Rao, counsel representing Sri P. Shiva Rao, learned Standing Counsel for the Respondents, has not raised any objection.

In view thereof, the Original Petition stands dismissed as withdrawn.
