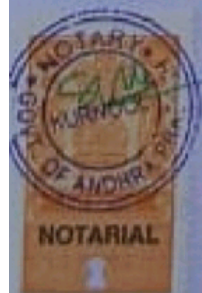

jurisdiction, as on 01-04-2024





- (b) The Revenue Gap (whether carried forward or not) as reflected in each ARR up to 01-04-2024
- (c) The trajectory/roadmap for liquidation of these Regulatory Assets/ ending the revenue gap up to 01-04-2024, so as to ensure that the entire Regulatory Assets/ Revenue Gap is liquidated latest by 31-03-2028
- (d) The steps taken by each of the Commissions to commence an intensive audit of the circumstances in which the Distribution Companies, operating within their jurisdiction, have continued to function without recovery of the Regulatory Assets/ Revenue Gap, and
- (e) The year up to which each of these Commissions have passed true up/ ARR orders with respect to each of the Distribution Companies within their jurisdiction
3. That in response to information sought by this Hon'ble Appellate Tribunal with regards to 2(a) stated hereinabove, it is most humbly submitted that based on the records maintained by the answering Regulatory Commission there is no Regulatory Asset/Revenue Gap required to be liquidated or recoverable from the retail tariff of the DISCOMs. As a consequence of which the information with regards to 2(b) to 2(d) stated hereinabove be taken as NIL.
4. That in response to information sought by this Hon'ble Appellate Tribunal with regards to 2(e) stated hereinabove, it is most respectfully submitted that the true up Petitions up to FY 2023-24 has been filed and as such the regulatory process is underway. It may however be pertinent to mention that the true up/ down charges for both Transmission and Distribution businesses have been provisionally considered in Retails Supply Tariff (RST) Orders for FY 2024-25. As such, the fuel cost adjustments up to FY 2023-

24 has already been completed. The DISCOMs were permitted a monthly recovery of fuel cost variations up to 40 paise per unit, subject to the final reconciliation which is conducted at the end of the Financial Year. Even though the fuel cost reconciliation is pending consideration / determination before the answering Regulatory Commission for passing of appropriate orders, as per the filings, the fuel cost adjustment for FY 2024-25 is net true down.


