These Interlocutory Applications having come up for hearing on 06-10-2021 in the presence of Sri A.P. Reddy, learned Counsel for the petitioner and Sri P. Shiva Rao, learned Standing Counsel for the respondents, and upon hearing the arguments of both the Counsel, the Commission passed the following:

ORDER:

Sri A.P. Reddy, learned Counsel for the petitioners, submitted that in identical matters, this Commission has granted interim order directing the respondents to pay interim tariff @ Rs.2.43 ps. Per unit from the 11th year onwards subject to the final

orders that may be passed in the O.Ps. Sri P. Shiva Rao, learned Standing Counsel for the respondents, has fairly admitted the said position.

In the light of the above, the respondents are directed to pay the petitioners interim tariff @ Rs.2.43 ps. per unit from the 11th year onwards pending further orders, which shall be subject to the final outcome of the O.Ps.

The I.As. shall accordingly stand disposed of.
