Shiva Rao, learned Standing counsel for respondent No.2, in the respective O.Ps., the Commission passed the following :

COMMON ORDER:

On behalf of the District Collector, Krishna at Machilipatnam, the District Revenue Officer is present at the hearing. He submitted that the District Collector is going to join the hearing soon. However, the Commission has received the proceedings in File No.REV-RTIOMIS(INF)/40/2021-JA(H7)-KCO, File No. REV - RTIOMIS (INF) / 41/2021-JA(H7)-KCO, dated 07-09-2021 and File No. REV - RTIOMIS(INF)/47/ 2021-JA(H7)-KCO, dated 05-09-2021 fixing the compensation, through e-mail.

Sri P. Chengal Reddy, learned Counsel for the petitioners, fairly submitted that with the passing of the order by the District Collector, the orders of this Commission stand complied with and that therefore the O.Ps. may be closed leaving the petitioners free to avail appropriate legal remedies if they feel aggrieved by the orders passed by the District Collector.

In the light of the above, the O.Ps. are disposed of placing on record the compliance of the orders dated 20-01-2018 in O.P.No.32/2017, 42/2017, 43/2017, 44/2017, 45/2017, dated 17-03-2018 in O.P.Nos.3/2017, 53/2017, 54/2017, 55/2017, 56/2017, 57/2017, 62/2017 and 63/2017, however, with liberty to the petitioners in terms of the prayer made.
