The petition has come up for hearing finally on 27-06-2015 in the presence of Sri S. Niranjan Reddy, learned counsel for the petitioner, Sri P. Shiva Rao, learned Standing Counsel for the AP Discoms and Sri Y. Rama Rao, learned Standing Counsel for TS Discoms are present. After carefully considering the material available on record and after hearing the arguments of both parties, the Commission passed the following:

## ORDER

Heard Sri S. Niranjan Reddy, learned counsel for the petitioner, Sri P. Shiva Rao, learned Standing Counsel for respondent Nos.1, 2, 4 and 6 and Sri Y. Rama Rao, learned Standing Counsel for respondent Nos.3 and 5.

The Original Petition is primarily seeking compliance with the orders of the erstwhile Andhra Pradesh Electricity Regulatory Commission dated 27-11-2012 passed in O.P.No.26 of 2012. In I.A.No.11 of 2015 in O.P.No.26 of 2012, compliance with the orders of the Hon'ble Supreme Court in the matter pending before it challenging the orders in O.P.No.26 of 2012 is under consideration and the respondents therein are in the process of complying with the said interim orders. Concerning the sustainability of the orders in O.P.No.26 of 2012, no further decision can be taken herein as of now in view of the pendency of the Civil Appeal before the Hon'ble Supreme Court and the interim orders passed by it during the pendency of the said appeal. Therefore it has been agreed by both the learned counsel that no useful purpose would be served as of now in keeping the petition pending. Hence, the petition is closed. No costs.

Remedies of the parties to pursue any relief granted by the Hon'ble Supreme Court ultimately in the Civil Appeal are left open.
