**ORDER:**

These I.As. have been filed in the respective O.Ps. for directing the respondents to pay generic tariff of Rs.3.43 ps. per Unit from the 11th and subsequent years pending the O.Ps.

At the hearing, learned Counsel for both the sides are agreed that in similar cases this Commission has directed the respondents to pay @ Rs.2.43 ps. per Unit from the 11th and subsequent years.

In view of the same, there shall be a similar interim order in these applications.

The I.As. shall stand disposed of accordingly.
