This Original Petition has come up for hearing on admission before us today in the presence of Sri Adarsh Kumar Bhardwaj, Counsel representing Sri Aniket Prasoon, learned Counsel for the Petitioners; and Sri G.V.Brahmananda Rao, counsel representing Sri P.Shiva Rao, learned Standing Counsel for the respondents; that considering the submission made on behalf of the learned counsel for the petitioners for withdrawing the Original Petition, this Commission passed the following:

ORDER

1. M/s. ACME Solar Holdings Ltd & five others (petitioners herein) have filed this Petition against APSPDCL, APTRANSCO, APSLDC & APPCC, (respondents herein) under Sections 142 & 149 of the Electricity Act, 2003, seeking initiation of proceedings/appropriate action against the Respondents for non-compliance of the Order dated 19.06.2024 passed by this Commission in OP No.17 of 2023 with respect to payment of 50% LPS in relation to 160 MW capacity. In the main OP the petitioners sought for the following reliefs:

- a) To direct the Respondents to comply with the Final Order dated 19.06.2024 passed by this Hon'ble Commission in O.P. No. 17 of 2023 with respect to payment of 50% LPS in relation to 160 MW capacity and accordingly, forthwith pay 50% of Late Payment Surcharge, on the delayed payments towards 160 MW capacity as per the PPAs;
- b) To initiate the proceeding under Sections 142 and 149 of the

- Electricity Act, 2003 against the Respondents for failure to comply with the directions of this Hon'ble Commission with respect to payment of 50% LPS in relation to 160 MW capacity;
- c) to award costs of these proceedings against the Respondents and in favour of the Petitioners; and
 - d) To grant such order, further relief(s) in the facts and circumstances of the case as this Hon'ble Commission may deem just and equitable in favour of the Petitioners.

2. Today, when the matter came up for hearing on admission, Sri Adarsh Kumar Bhardwaj, Counsel representing Sri Aniket Prasoon, learned Counsel for the Petitioners, seeks permission of the Commission to withdraw the present Petition with a liberty to file fresh Petitions.

3. Considering the aforesaid request made on behalf of the learned counsel for the petitioners, the Original Petition is dismissed with liberty as prayed for.
