ORDER:

Sri V.V.N.Narayana Rao, learned counsel, representing respondents 1 and 2, is present along with respondent No.2 and filed his vakalat on their behalf. On behalf of respondent No.3, Sri P. Shiva Rao, learned Standing Counsel, is present along with Sri Chandram Dandagala, Director (Finance) of respondent No.3.

The Chairman and Managing Director of respondent No.3 filed an affidavit stating that steps are already taken for collecting July bills (for consumption of electricity for the month of June, 2022). On the query of the Commission, Sri Chandram, Director (Finance) of respondent No.3, submitted that as the staff of

respondent No.1 are not co-operating in raising the bills, he will deploy the staff of

respondent No.3 and ensure that the bills are served on the consumers and CC charges

are collected before the end of this month. Till the application for exemption is

decided, respondent No.3 shall issue bills in its name by deploying its own staff and

credit the collected amounts in its own account.

Sri V.V.N. Narayana Rao, learned counsel for respondents 1 and 2, submitted

that he will appropriately advise his clients and file a detailed affidavit within one

week. He further submitted that he is assuring on behalf of his clients that, in

obedience to the interim order passed by this Commission, respondents 1 and 2 will

not interfere with the activity of distribution and supply of power and recovery of CC

charges by respondent No.3.

By the next date of hearing, the Chairman and Managing Director and the

Director (Finance) of respondent No.3 shall be personally present and file an affidavit

narrating the steps the respondent No.3 has taken to comply with the interim order

already granted and the directions contained in the present order.
