This Original Petition has come up for hearing before us today in the presence of Ms.Priya Dhankar, counsel representing Shri Sri Venkatesh, learned counsel for the petitioner; and Sri P. Shiva Rao, learned Standing Counsel for the respondents, that after carefully considering the material available on record and after hearing learned counsel for both the parties, the Commission passed the following:

ORDER

This Original Petition is filed under Section 86(1)(f) read with Section 86(b) of the Electricity Act, 2003, for the following reliefs:

- i) To allow the present petition and declare that the deduction of Rs.9.72,00,000/- (Rupees Nine Core, Seventy Two lakhs only) and Rs.96,48,000/- (Rupees Ninety Six Lakh, Forty Eight Thousand only) by the respondents 1 to 5 towards alleged compensation claim for non-supply of short term power by the petitioner from UTWR1 AND CPP in ER(DEC) respectively are illegal and wrongful;
- to direct the respondents No.1 to 5 to pay jointly and /or severally an amount of Rs.10,68,48,000/- Rupees Ten Crore, Sixty Eight lakh, and Forty Eight thousand only) to the petitioner together with interest at the rate of 15% per annum;

- iii) to direct the Respondents to pay the costs and expenses of the present proceedings to the petitioner; and
- to pass other and further orders/directions as the Honourable Commission may deem appropriate in the facts and circumstances of the case.

Ms.Priya Dhankar, counsel representing Shri Sri Venkatesh, learned counsel for the petitioner, submitted that in view of certain events transpired after filing of this petition, the petitioner seeks to withdraw this petition with liberty to the petitioner to approach the Central Electricity Regulatory Commission, New Delhi, for appropriate reliefs; and she, accordingly, seeks permission to withdraw this petition.

Having regard to the aforesaid submission of the learned counsel for the petitioner, this Original Petition is dismissed as withdrawn with liberty to the petitioner in terms of the prayer made.
