This Petition has come up for hearing before us today in the presence of Sri A.P.Reddy, learned counsel for the petitioner, and Sri P. Shiva Rao, learned Standing Counsel for the respondents, and upon considering the material available on record and after hearing the arguments of the learned counsel for both parties, the Commission passed the following:

## **ORDER**

This O.P., is filed for the following relief:

"In view of the above the Petitioner respectfully prays that this Honourable Commission may be pleased to:

- a) Direct the respondent No.1 to make the outstanding payments aggregating to Rs.28,63,363/- (Rupees Twenty eight lakhs sixty three thousand, three hundred and sixty three only) towards the monthly bills issued by the petitioner for supplying the power generated from the Project into the State power grid along with the delay surcharge calculated upto 29-10-2020;
- b) Direct the Respondent No.1 to open a revolving Letter of Credit for a minimum period of 1 year in favour of the petitioner in terms of Clause 5.3 of Power Purchase Agreements dated 21-4-2010; and
- c) Pass such and further order(s) as this Honourable Commission thinks fit and proper in the present case".

At the hearing, Sri P.Siva Rao, learned Standing Counsel for the respondents, submitted that the respondents have paid the entire arrears as claimed in this O.P.

Sri A.P. Reddy, learned counsel for the petitioner, has not disputed the said submission.

As the grievance of the petitioner substantially stands redressed, the O.P., is disposed of.
