This Petition has come up for hearing before us today in the presence of Sri S.Rahul Reddy, learned counsel for the petitioner, and Sri P. Shiva Rao, learned Standing Counsel for the respondent, and upon considering the material available on record and after hearing the arguments of the learned counsel for both parties, the Commission passed the following:

<u>ORDER</u>

This O.P., is filed for the following relief:

"It is therefore humbly prayed that this Hon'ble Commission may be pleased to declare the action of the Respondent in unilaterally reducing the tariff from 6.7362/kwh to Rs.2.44/kwh as illegal, without jurisdiction, violative of Articles 14,19(1)(g), 21 and 300-A of the Constitution of India and consequently direct the Respondent herein to settle and pay amounts due to the Petitioner as per the tariff agreed with increment of 3% per annum of the agreed tariff or Rs.5.99/kwh till the end of the 10th year of such supply and the increased tariff of the 10th year till 25 years as mentioned in the PPA and pass such other order or orders or directions as this Hon'ble Commission deems fit and necessary in the facts and circumstances of the case and in the interest of justice and equity".

At the hearing, Sri P.Siva Rao, learned Standing Counsel for the respondent, submitted that the respondent has paid the entire arrears as claimed in this O.P.

Sri S.Rahul Reddy, learned counsel for the petitioner, has not disputed the said submission.

In the light of the above, the prayer in the O.P. worked itself out. The O.P. is, accordingly, disposed of.
