These original petitions have come up for hearing before us today in the presence Sri Deepak Chowdary, counsel representing Sri Challa Gunaranjan, learned counsel for the petitioner; that after hearing the learned counsel for both parties, and that after carefully considering the material available on record the Commission passed the following:

COMMON ORDER

These OPs are filed with the common grievance that, though the Petitioners are agreeable for waiver of 50% of the LPS, the Respondent have not been paying the same. On the previous occasion this Commission has directed the both parties to reconcile with the accounts and arrive at a consensus if possible on the LPS amounts payable. Today, the Respondents have filed a Memo along with a reconciliation statement of LPS signed by both parties. Sri Deepak Chowdary, learned counsel for the petitioner in these OPs has fairly agreed that the parties have reconciled with the quantum of 50% of the LPS payable. Sri P. Shiva Rao, learned standing counsel submitted that the Respondent may be allowed to pay the amount in four monthly instalments. However, considering the fact that the amounts are not very substantial and there is already delay in making payments, we allow the Respondents to pay the amounts in two monthly instalments commencing from 1st October 2024. The OPs are accordingly disposed of.
