The Original Petition came up for final hearing before this Commission on 07-02-2024 in the presence of Sri Deepak Chowdary, learned Counsel for the Petitioner; and Sri P.Shiva Rao, learned Standing Counsel for the respondents, that after hearing the learned counsel for both the parties and after carefully considering the material available on record, this Commission made the following :

---

**ORDER**

Sri Deepak Chowdary, learned counsel for the Petitioner; and Sri P.Shiva Rao, learned Standing Counsel for the respondents, are present at the hearing.

This OP is filed with the main grievance that, the Petitioner is denied payment of UI charges for over injection to the tune of Rs. 53,80,233/- for the period from 01-01-2021 to 15-11-2022. At the hearing Sri P. Shiva Rao, learned standing counsel for the Respondents placed before us an email addressed from APTRANSCO, EBC, to the Petitioner's representative, wherein, it is inter-alia stated that the Respondents through the said email confirmed that the revised computation of deviation charges shared by the Petitioner aligns with the APERC's DSM Regulation which necessitates revision of DSM demand charges raised by APSPDCL.

Sri P. Shiva Rao, learned standing counsel for the Respondent has submitted that, APSPDCL has been requested to revise the computation of deviation charges and that the latter is in the process of issuing the same.

Sri Deepak Chowdary, learned counsel for the Petitioner did not dispute the above position. With the acceptance of the Petitioner's computation of deviation charges as per APERC's DSM Regulations, by the APTRANSCO, the grievance of the Petitioner stands redressed. Further, the submission of Sri P. Shiva Rao that the APSLDC would carryout the revised computation of deviation charges as proposed by the Petitioner and consequent credit note

would be issued in favour of the Petitioner, is placed on record.

The OP is accordingly closed.
