PRESS NOTE

Fuel and Power Purchase Cost Adjustment (FPPCA) Order for FY 2022-23

The AP Electricity Regulatory Commission (APERC), Kurnool, issued an FPPCA Order for FY 2022-23 today, disposing of OP NOs 57 to 68 of 2024 after a comprehensive public consultation process and public hearing on 18.10.2024, where the Commission carefully considered all public objections, views, and suggestions. The Order may be downloaded from the Commission's website: www.aperc.in, The summary of the Order is as below.

1. The Commission approved the FPPCA recovery of Rs.6072.86 crores from the consumers who consumed power during FY 2022-23, as against Rs. 8114 crore recovery proposed by the DISCOMS, which is less by 2042 crores.
2. The Commission did not consider DISCOMS' request to allow carrying costs(Interest)
3. The Commission directed the DISCOMS to recover FPPCA charges in 15 months instead of in one lump sum to avoid hardship and tariff shock to the consumers.

The DISCOMS were directed to recover the FPPCA regarding agricultural consumption under the free power category consumers and other subsidised or partly subsidised consumers from the government of Andhra Pradesh. This would amount to approximately 1400 Crores out of the Rs.6072 crores recovery approved and benefit 20 lac consumers.
