APCPDCL on behalf of APDISCOMs do hereby submit that APCPDCL has requested Hon'ble APERC vide ref (5) cited for according approval for procurement of power from Teesta-VI and Rangit-IV Hydro Electric Projects of M/S NHPC and its IVs/subsidiaries as allocated by Ministry of Power, Govt. of India.

Further, Ministry of Power, Govt of India vide ref (4) cited has allocated firm power to Andhra Pradesh from Ratle (850MW), Pakal Dul (1000MW) and Kwar (540MW) Hydro Electric Projects of M/S NHPC Ltd as follows.

NHPC vide reference 4th cited has communicated draft PPAs for the HEPs and also mentioned that all these projects are eligible for 100% ISTS charges waiver if PPAs are signed by June 2025. With reference to the eligibility for 100% ISTS charges waiver, it is to submit that the ISTS charges are exempted to NHPC projects for the power drawal blocks from Hydro Electric projects only but not on round-the-clock basis on par with the methodology communicated in Annexure-III of the CERC Sharing of ISTS Charges Regulation, 2020 First
