Venues for Public hearings on ARR, Tariff & CSS proposals of the DISCOMs of RSB for FY2026-27,

In continuation of the Public Notice dated 10.12.2025 issued in newspapers by APDISCOMS, it is hereby informed that the Commission has decided to conduct public hearings through a hybrid method (i.e., in-person and through video conference) on ARR, Tariff, and Cross Subsidy Surcharge (CSS) filings for the Retail Supply Business for FY 2026-27 under Section 62 of the Electricity Act, 2003, in the O.P. Nos. 75, 76 and 77 of 2025 for APSPDCL, APCPDCL and APEPDCL, respectively. The dates, timings, details of venues and the detailed guidelines for public participation through video conference for public hearings are as follows:

Note: The morning session, 10.30 AM/11.00 AM to 1.00 PM/1.30 PM, will be in-person, and the afternoon session, 2.00/2.30 PM to 4.30 PM, will be via video conference. However, these timings will be modified, if necessary, by the Commission depending on public participation each day.

Detailed guidelines for public participation through video conference

1. The person(s) who are desirous of being heard via video conference at the public hearings shall inform the DISCOM in advance of their intent to be heard, with a copy to the Commission. The intent should mention the nearest SE/Executive Engineer/Divisional Engineer Office through which the member of the person(s) likes to present their views. The intent shall also mention the date he/she would like to be heard.
2. The DISCOM shall serially number all such requests received by it and include a date and time stamp.
3. The DISCOM shall compile all such requests and communicate to the Commission a chronological list of the requests received.
4. The Commission shall, duly taking into account other exigencies, if any, host on its website the list of the person(s) who are scheduled to present their views- S.No, Name, Date & SE, EE /DE office. The same list will be communicated to the respective DISCOM.
5. On receipt of this list, the DISCOM shall make the necessary arrangements to ensure that the person(s) can present their views on the scheduled date of their presentation/submission.
6. If any SE/DE/EE Office receives requests from persons who have not communicated earlier their intent to make their oral submissions on any hearing day, the SE/DE/EE concerned shall communicate the same to the Commission through video conference on that date of hearing, after all the scheduled persons are heard. If permitted by the Commission, such persons can then make their submissions. Further, each DISCOM shall, upon request, provide a separate meeting link to enable the general public to present their objections via VC from their personal gadgets without visiting the SE/DE's office.
