Blyth Wind Park Private Limited Vs APSLDC, APTRANSCO, APSPDCL & APEPDCL

Petition under Section 86(1)(f) of the Electricity Act, 2003 for adjudication of disputes arising out of (a) undue delay in issuance of Settlement Reports ; and (b) Settlement being processed by the Energy Billing Centre, Andhra Pradesh State Load Despatch Centre, operated by Transmission Corporation of Andhra Pradesh Limited, in contravention of the provisions of the Andhra Pradesh Electricity Regulatory Commission (Interim Balancing and Settlement Code) Regulations, 2006 and the amendments thereto.

Application filed by M/s. Blyth Wind Park Pvt Ltd u/s 94 (2) of the Electricity Act, 2003 in O.P.No. 24 of 2020 seeking interim relief by way of directions to Energy Billing Centre, APTRANSCO / APSLDC to immediately settle the energy account of the petitioner in terms of the APERC (Interim Balancing and Settlement Code) Regulations 2006 and the amendments thereto.

Ms. Mazag Andrabi, learned counsel for the petitioner and Sri P. Shiva Rao, learned Standing Counsel for the respondents are present at the web hearing.

Counter Affidavit is filed. At the hearing both the learned counsel have agreed that the respondents have made settlement of energy in consonance with the Regulation framed by this Commission, instead of following GO.Ms. No. 35 Dt.18-11-2019.
