This IA is filed under Section 142 of the Electricity Act, 2003 r/w Clause 55 of the APERC (Conduct of Business) Regulations, 1999 for punishment of the APSPDCL for non-compliance of the direction issued by this Commission in the order dated 5-7-2021 passed in O.P.No.20 of 2020 by this Commission

Md. Mukhairuddin, learned counsel for the Petitioner; and Sri G.V.Brahmananda Rao, counsel representing Sri P.Shiva Rao, learned Standing Counsel for the Respondents, are present at the hearing.

This I.A. is filed for a direction to respondent No.1 to comply with Order dated 05-7-2021 passed by this Commission in O.P.No.20 of 2020.

At the hearing, the learned counsel for both the parties agreed that a sum of Rs.1,27,64,414/- (Rupees one crore, twenty seven lakhs, sixty four thousand, four hundred and fourteen only) has been credited to the petitioner's account by respondent No.1. The learned

counsel for the petitioner filed a memo saying that still a sum of Rs.2,02,797/- (Rupees two lakhs, two thousand, seven hundred and ninety seven only) is due and payable by respondent No.1 to the petitioner.

A clarificatory memo to the aforesaid memo has been filed by respondent No.1, wherein it has been, *inter alia*, stated as under:

"On verification of the Joint Metre Reading submitted by the petitioner from 29-3-2017 to 23-3-2020 the energy supplied by the petitioner is 44,08,100 units before line loss. After adjusting the line losses as per PPA Article-1, Explanation-3, the admissible energy is 43,59,230 units and payment shall be arranged at Rs.2.93 per unit. As per the above calculations an amount of Rs.1,27,72,544/- shall be paid to the petitioner before recovery of Reactive energy and TDS, after adjustment of recovery towards reactive energy amount (i.e., Rs.359/-) and TDS amount (i.e., Rs.7,772/-) an amount of Rs.1,27,64,414/- shall be paid to the petitioner"

In view of the above clarification given by respondent No.1, the claim of the petitioner that a further sum of Rs.2,02,797/- (Rupees two lakhs, two thousand, seven hundred and ninety seven only) is payable by the respondent No.1, is not sustainable.

As the order of this Commission has been complied with, the I.A. is closed.
