The review petition has come up for hearing finally on 31-10-2015 in the presence of Sri P. Shiva Rao, learned Standing Counsel for the Petitioners 2, 4 & 5 and Sri J. Ashwini Kumar, learned counsel representing Sri Y. Rama Rao, learned Standing Counsel for the Petitioners 1 & 3 and Smt. M. Indrani, learned counsel representing Sri Challa Gunaranjan, learned counsel for the respondent are present. After carefully considering the material available on record and after hearing the arguments of the counsel, the Commission passed the following:

ORDER

Smt. M. Indrani, learned counsel for the respondent filed a Memo stating that this review petition becomes *infructuous* in view of Regulation 1 of 2015 dated 31-07-2015 and hence, requested for closing the petition. Sri P. Shiva Rao, learned Standing Counsel for the petitioners 2, 4 & 5 and Sri J. Ashwini Kumar, learned counsel representing Sri Y. Rama Rao, learned Standing Counsel for the petitioners 1 & 3 expressed no objection for closing the petition in view of the changed circumstances consequent to the bifurcation of the State and independent policies in this regard being adopted by both the States and respective State Governments extending further benefits in the matter. The learned Standing Counsel also submitted that this review petition has been more necessitated by the respondents filing RP (SR) No.62 of 2013, which petition has been dismissed today at the instance of the respondents herein as having becoming *infructuous*. The learned counsel for both parties are unanimous about the absence of any necessity for this review petition now. Hence, this petition is dismissed as no longer necessary. The parties shall bear their own costs.
