

Gopal Choudary learned counsel for the petitioner and Sri P. Shiva Rao, learned Standing Counsel for the respondents. After carefully considering the material available on record and after hearing the arguments of parties present, the Commission passed the following:

ORDER

Heard Sri S.V.S.S. Siva Ram, learned counsel representing Sri K. Gopal Choudary, learned counsel for the petitioners and Sri P. Shiva Rao, learned Standing Counsel for the respondents. The Hon'ble High Court in orders in a batch of Writ Petitions on 27-04-2016 set aside the orders of this Commission dated 15-04-2015 in O.P.No.8 of 2015 determining the Cross Subsidy Surcharge and Additional Surcharge for FY 2015-16.
