Petition filed Under Section 62 of the Electricity Act, 2003, r/w. APERC (Conduct of Business Regulation, 1999) for determination of tariff for a period of 15 years i.e. from the 25th year to 40th year of operation for the Power Purchase Agreement (PPA) dated.06.01.2025 for 1.4 MW Capacity 'Mini Hydel Power' entered into between the Petitioner and the Respondent Discom's.

IA No.1 of 2025 in OP No. 7 of 2025

This is an Interlocutory Application filed by APCPDCL under section 62 of Electricity Act 2003 read with 86 1 (b) and Section 94 (2) seeking interim order

for procurement of power from M/s. Active Power Corporation Pvt Limited at an ad hoc tariff pending approval of PPA.

It has been observed that, in a few cases, APDISCOMs are procuring power from generators without obtaining prior approval from the Commission, and are instead seeking approval retrospectively. This practice undermines the regulatory authority of the Commission.

In the present case, Sri N.Sai Phanindra Kumar, learned Counsel for M/s. Active Power Corporation Private Limited has confirmed that their generator has not yet supplied power to the APDISCOMs, as also reiterated by Sri A.S.Narasimha Rao, DGM/RE/APPCC representing APDISCOMs.

Henceforth, APDISCOMs are directed not to procure power without obtaining proper prior approval from the Commission.

Accordingly, the Interlocutory Application (IA) is allowed.

OP No. 7 & 16 of 2025

Since these OPs relate to approval of the PPA and determination of tariff, it must be placed in the public domain. The office shall place material available on record on the home page of Commission's website for the reference of all stakeholders. Accordingly, M/s. Active Power Corporation Private Limited shall carry out publication of their petition in OP No. 16 of 2025 in two widely circulated newspapers - one in Telugu daily and the other in English daily - of the Andhra

Pradesh Editions within a week. The publication shall invite objections/suggestions from all stakeholders, allowing a period of 15 days for submission. M/s. Active Power Corporation Private Limited shall also file proof of publication with the Commission's office. Furthermore, M/s. Active Power Corporation Private Limited & APDISCOMs are directed to submit their responses to the objections received, within 15 days thereafter.
