EIGHTH AMENDMENT TO THE ANDHRA PRADESH ELECTRICITY REGULATORY COMMISSION (CONDUCT OF BUSINESS) REGULATIONS, 1999 (REGULATION NO. 2 OF 1999).

[REGULATION NO. 8 OF 2023]

#### Introduction:

With the amendments to the APERC (Terms and Conditions for Determination of Tariff for Wheeling and Retail Sale of Electricity) Regulation,2005 (Regulation No. 4 of 2005), clauses 45-A ("Expected revenue from charges and tariff proposals") and 45-C ("Subsidies") under chapter IVA of the Andhra Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations, 1999, hereinafter referred to as 'The Principal Regulations', have become infructuous.

In light of the above, the Commission decided to amend the Principal Regulations appropriately. Accordingly, the Commission hosted a draft eighth amendment to the said Regulation on its website inviting interested stakeholders to submit their comments/suggestions/objections to the Commission by 05.08.2023. The Commission has not received any comments/suggestions/objections to the said draft amendment. Therefore, the Commission, in exercise of powers conferred on it under section 181 of the Electricity Act, 2003 (36 of 2003), and all powers enabling it in that behalf, hereby issues the eighth amendment to the Andhra Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations, 1999 as under:

### Part-1 GENERAL

#### 1. Short title and commencement:

- (i) These Regulations shall be called the Eighth Amendment to the Andhra Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations, 1999.
- (ii) These Regulations shall come into force with effect from the date of its publication in the Official Gazette.

#### 2. Amendment to clauses 45-A and 45-C of the Principal Regulations:

Regulation 45-A (Expected Revenue from charges, and tariff proposals), and Regulation 45-C (Subsidies) in Chapter IV (A) of the Andhra Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations,1999 shall stand **DELETED**.
