To the persistent queries of the Commission, Sri P. Shiva Rao submitted that it is only a few officers of the Discoms who sit in the APPCC's office and take decisions with

the approval of the JMD, A.P. Transco to buy or sell power, that neither the CMDs nor the Board of Directors are made aware of these real-time decisions and that they are informed about the same *post facto*. The Commission would like to know as to what is the statutory authority of a bunch of Discoms' officers to take decisions on behalf of the Discoms without even the knowledge of the CMDs and the other Directors of the Board. Sri P. Shiva Rao requested for time for filing appropriate affidavit answering this query. The Review Petition is therefore adjourned, however, informing the learned Standing Counsel that the pendency of the Review Petition will not deter the Commission from initiating the proceedings under Sections 142 and 146 of the Electricity Act 2003 for non-compliance of the direction to provide link w.e.f. 1-4-2021.
