Sri. Basava Prabhu Patil, learned Senior Counsel and Mr. Shri Venkatesh, learned counsel for the petitioner and Sri P. Shiva Rao, learned Standing Counsel for the respondents are present at the web hearing.

We have heard the learned senior counsel for the petitioner and Sri P. Shiva Rao, learned standing counsel for the respondents.

As regards the request of the learned Senior Counsel for the petitioner for disposal of the O.P., Sri P.Shiva Rao, learned Standing Counsel for the respondents, submitted that one of the issues argued before the Honourable High Court of Andhra Pradesh relates to tariff at which the payment has to be made even in respect of the petitioner, pending adjudication of the O.Ps., filed before the Commission. The learned Senior Counsel, however, disputed this submission.

The learned Senior Counsel for the petitioner submitted that the respondents are in huge arrears and that the petitioner has been facing severe financial crunch on account of non-payment of bills by the respondents. The petitioner sought recovery of about Rs.351 crores as on 19-1-2021 and according to the learned Senior Counsel the arrears have further mounted upto Rs.432.43 crores of principal amount. As some related issues are pending before the Honourable High Court of Andhra Pradesh, we defer adjudication of the O.P., for the time being. However, to relieve the petitioner of the financial hardship being faced by it due to non-payment of even admitted liability by the respondents, we are of the opinion that the respondents shall clear the arrears in reasonable instalments, pending disposal of the O.P.

Accordingly, the respondents, to start with, shall pay a sum of Rs.75.00 crores (Rupees seventy five crores) on or before 31-03-2022.

Call the O.P. on 06-04-2022 for reporting compliance of the above direction in respect of the payment of Rs.75 crores and also for issuing similar directions for payment for subsequent months.
