In pursuant to the subject matter and the directions contained in the reference letter cited, the information on items (1) & (2) is enclosed for consideration of the Hon'ble Commission.

- 1. Auditors certificates for the costs incurred to each Generator
- 2. Certified copies of the cumulative availability of different Generating stations for the relevant years.

Further, on behalf of the AP DISCOMs the following points are submitted.

- at While filing the True-Up petitions for the relevant years, the APDISCOMs have taken the claims of different Generalors and Transmission costs particularly in the cases of AP Genco and APPDCL as they were made available to the DISCOMS.
- b) Hon'ble Commission has determined the fixed costs of SDSTPS stage(1) on 02.03.2019. Till then adhoc tariff has been paid to SDSTPS. DISCOMs have to incur additional fixed cost in respect of SDSTPS for FY15-16, FY16-17. The same was taken into books of accounts in the FY 2018-19.
- c) Further, APDISCOMs have decided to pay the fixed costs up to the Contracted Capacity of 90% of installed capacity in SDSTPS as per the orders of Hon'ble APERC and accordingly, adjustments have been made to the overall fixed charges payable to the plant.
- d) Based on the plant availability certifications for the Year FY 2018-19 issued by APSLDC, the Fixed Cost & Fuel Cost Adjustment Claims payable to the SDSTPs are recast and an amount of Rs 1875.80 Cr & Rs. 249.80 Cr respectively, totaling to a tune of Rs. 2125.60 Cr. is to be knocked off from the claims of SDSTPS and accordingly withdrawn from the True-up claims.
