1. G.S.R. 217 (E), Ministry of Power, Government of India, dated. 18-04 1006.

2. From the Chairperson and Managing Director, APTRANSCO, Hyderabe L.L. No. CE (RAC of Reforms) AAO/E. Act-03/D. No. 286/2006, dated 25-1 - 2006.

In the reference first read above, the Government of India have issued the Works of Licensees Rules, 2006 under section 176(2)(e) read with section 67 (1) of the Electricity Act, 2003.

In the reference second read above, the Chairperson and Managing Director APTRANSCO, Hyderabad has sent the draft Rules for application of such it less in the late of Andhra Pradesh.

The Government after careful consideration of the said rules have decide the rules similar to those issued by the Government of India for the State of Pradesh.

In exercise of the powers conferred by clause (b) of sub-section (2) of se read with sub-section (2) of section 67 of the Electricity Act, 2003 (Act No.36 the Governor of Andhra Pradesh hereby makes the following rules.

Rules:

- 1. Short title and commencement. (1) These rules may be called the Andhra Works of Licensees Rules, 2007.
- (2) They shall come into force on the date of their publication in the Official Gaz
- 2. Definitions: (1) In these rules unless the context otherwise requires,-

(a) "The Act' means the Electricity Act, 2003;

- (b) "Occupier of any building or land" means a person in lawful occupation building or land.
- (c) 'The State Government' means Government of Andhra Pradesh.
- (d) 'The Commission' means Andhra Pradesh Electricity Regulatory Comm
- (2) All other words and expression used herein and not defined in these n have the meanings respectively assigned to them in the Act.
- 3. Licensee to carry out works .- (1) A licensee may -
 - (a) carry out works, lay down or place any electric supply line or other fhrough, or against, any building, or on, over or under any land whereover or whereunder any electric supply-line or works has no been lawfully laid down or placed by such licensee, with the prior c the owner or occupier of any building or land;
 - (b) fix any support of overhead line or any stay or strut required for the of securing in position any support of an overhead line on any buland or having been so fixed, may alter such support:
- (2) Provided that in case where the owner or occupier of the building or la objections in respect of works to be carried out under this rule, the licens obtain permission in writing from the District Magistrate or the Commissioner of the officer authorised by the State Covernment in this behalf, for our

provided further that if at any time, the owner or occupier of any building or land on ich any works have been carried out or any support of an overhead line, stay or strut been fixed shows sufficient cause, the District Magistrate or the Commissioner of lice, or the officer authorized may by order in writing direct for any such works, poort, stay or strut to be removed or altered.

- When making an order under sub-rule (1), the District Magistrate or the ommissioner of Police or the officer so authorised, as the case may be, shall fix, after insidering the representations of the concerned persons, if any, the amount of impensation or of annual rent, or of both, which should in his opinion be paid by the censee to the owner or occupier.
- Byery order made by a District Magistrate or a Commissioner of Police or an athorised officer under sub-rule (1) shall be subject to revision by the Commission.
- 6) Nothing contained in this rule shall affect the powers conferred upon any licensee inder section 164 of the Act.
- works affecting streets, railway, tramway, canal or waterway:- (1) Where the fixercise of any of the powers of a licensee in relation to the execution of any works involves the placing of any works in, under, over, along or across any street, part of a treet, railway, tramway, canal or waterway, the licensee shall serve upon the person esponsible for the repair of the street or part of a street (hereinafter referred to as "the epairing authority") or upon the person for the time being entitled to work the railway, ramway, canal or waterway (hereinafter referred to as "works authority"), as the case may be, a notice in writing, not less than (15) days before commencing the execution of he works describing the proposed works, together with a section and plan thereof on a scale sufficiently large to show clearly the details of the proposed works, and not in any asse smaller than one inch to eight feet vertically and sixteen inches to the mile sorizontally and intimating the manner in which, and the time at which, it is proposed to interfere with or alter any existing works, and shall, upon being required to do so by the repairing authority or works authority, as the case may be, from time to time give such further information in relation thereto as may be desired.
- (2) If the repairing authority intimates to the licensee that it disapproves of such works, section or plan giving reasons for disapproval, or approves thereof subject to amendment, the licensee may, unless settled by an agreement, appeal to the Commission within one week of receiving such intimation, whose decision, ofter considering the reasons given by the repairing authority for its action, shall be final.
- (3) If the repairing authority fails to give notice in writing of its approval or disapproval to the licensee within (15) days of the receipt of the notice, it shall be deemed to have approved of the works, section and plan, and the licensee, after giving not less than forty-eight hours' notice in writing to the repairing authority, may proceed to carry out the works in accordance with the notice and the section and plan served under sub-rule (1);

- (4) If the works authority disapproves of such works, section or plan givin disapproval, or approves thereof subject to amendment, he may, within (15) service of the notice under sub-rule (1) of rule 5, serve a requisition upor demanding that any question in relation to the works or to compensation obligations of the works authority to others in respect thereof, shall be deten settled by agreement, by the Commission.
- (5) Where no requisition has been served by the works authority upon the lice the time period provided under sub-rule (4), the works authority shall be deen approved of the works, section and plan, and in that case, or where after the been determined by the *Commission*, the works may, upon payment or compensation, be executed according to the notice and the section and plan such modifications as may have been determined by the *Commission* or a between the parties:

Explanation: In sub-rules (1) to (5), the word "works" includes a ser under, over, along or across a railway even if such line is immediately intended to be immediately attached to a distributing main, but does any other service line so attached or intended to be so attached to a main, or works which consist of the repair, renewal or amendment works of which the character or position is not to be altered.

- (6) Where the works to be executed consist of the laying of any underground a immediately attached, or intended to be immediately attached, to a distributing licenses shall give to the repairing authority or the works authority, as the cannot less than forty-eight hours notice in writing of his intention to execute such

- 5. Recairs and works during emergency:- (1) The licensee may, in case of each due to the breakdown of an underground electric slapply-line, after information place an overhead line without complying with the provisions of rule 4.
- (2) Provided that such overhead line shall be used only and the defect underground electric supply-line can be made good, and in no case (unless written consent of the repairing authority, works authority or company as the case for a period exceeding six weeks, and shall be removed as soon. may be at defect is removed.

works:- (1) The licensee or any duly authorised person, as the case may be (hereinafter life rule referred to as "the operator"), shall -

- (a) where the licensee requires to dig or sink any trench for laying down any new electric supply-lines or other works, near to which any sewer, drain, water-course or work under the control of the State Government or of any local authority, or any pipe, syphon, electric supply-line or other work belonging to any duly authorised person, has been lawfully placed, or
- (h) where any duly authorised person is required to dig or sink any trench for laying down or constructing any new pipes or other works, near to which any electric supply-lines or works of a licensee have been lawfully placed;

Where the operator (being the licensee) lays any electric supply-line across, or so as be liable to touch, any pipes, lines or service-pipes or service-lines belonging to any authorised person or to any person supplying, transmitting or using energy under the ct, he shall not, except with the written consent of such person and in accordance with cregulations on safety as specified under section 53 of the Act, lay his electric supply-lies so as to come into contact with any such pipes, lines or service-pipes or service-lies.

Where any difference and/or dispute arises under this rule, the matter shall be commission.

Where the licensee is a local authority, the references in this rule to the local authority of the sewers, drains, water-courses or works under its control shall not apply.

- (3) The owner may, within fourteen days after the service of the notice, section and it serve upon the operator a requisition to the effect that any question arising upon notice, section or plan, shall, unless settled by agreement, be determined by; Commission, and thereupon the matter shall be determined by the Commission.
- (4) The Commission to whom a reference is made under sub-rule (3), shall have regate any duties or obligations which the owner is under, and may require the operator execute any temporary or other works so as to avoid, as far as possible, interference therewith.
- (5) Where no requisition is served upon the operator under sub-rule (3) within the limit, or where such a requisition has been served and the matter has been settled agreement or determined by the Commission, the alteration may, upon payment securing of any compensation accepted or determined by the Commission, be execute accordance with the notice, section and plan and subject to such modifications any upon between the parties or as may have been determined by the Commission.
- (6) Where the operator desiring to make the alteration makes default in complying any of these provisions, he shall make full compensation for any loss or damage incurby reason thereof, and, where any difference or dispute arises as to the amount of s' compensation, the matter shall be determined by the Commission.

Where the owner or occupier desires to carry out certain works himself,-

- (i) he may, at least ten days before the operator desiring to make the alteration of pipes or wires is entitled to commence the alteration, serve upon the operator a statement in writing to the effect that he desires to execute the alteration himself and requires the operator to give such security for the repayment of any expenses as may be agreed upon or, in default of agreement, determined by the Commission;
- (ii) where a statement is served upon the operator under clause (i), he shall, not less than forty-eight hours before the execution of the alteration is required to be commenced, furnish such security and serve upon the owner a notice in writing intimating the time when the alteration is required to be commenced, and the manner in which it is required to be made; and thereupon the owner may proceed to execute the alteration as required by the operator.
- (iii) where the owner declines to comply, or does not, within the time and in the manner prescribed by a notice served upon him under clause (ii), comply with the notice, the operator may himself execute the alteration;
- (iv) all expenses incurred by the owner in complying with a notice served upon him by the operator under clause (ii) may be recovered by him from the operator.

Works not repairable by the State Government, licensee or local authority.

The licensee shall open or break up any street not repairable by the State Government or a local authority only with the written consent of the person by whom the treet is repairable or with the written consent of the State Government:

- (2) Provided that the State Government shall not give any such consent as aforesaid, until the licensee has given notice by advertisement or otherwise as that the State Government may direct, and within such period as the that Government may fix in this behalf, to the person above referred to, and until all representations or objections received in accordance with the notice have been considered by the that the State Government.
- 9. Procedure for fencing, guarding, lighting and other safety measures relating to works and immediate reinstatement of streets, railways, sewers, drains or tunnels:-
- (1) Where any person, in exercise of any of the powers conferred by or under these rules opens or breaks up the soil or pavement of any street, railway or tramway, or any sewer, drain or tunnel, he shall-
 - (a) immediately cause the part opened or broken up to be fenced and guarded and

- (b) cause a light or lights, sufficient for the warning of passengers before to be set up and maintained until sunrise against or near the part opened
- (c) make suitable arrangements for smooth flow of traffic;
- (d) fill in the ground and reinstate and make good the soil or pavemer sewer, drain or tunnel, opened or broken up with all reasonable speed, a away the rubbish occasioned by such opening or breaking up; and
- (e) after reinstating and making good the soil or pavement, or the sewer, tunnel broken or opened up, keep the same in good repair for three months any further period, not exceeding nine months, during which sub
- (2) Where any person fails to comply with any of the provisions of sub-rule (person having the control or management of the street, railway, tramway, sewer, d tunnel in respect of which the default has occurred, may cause to be executed the which the defaulter has delayed or omitted to execute, and may recover from h expenses incurred in such execution.
- (3) Where any difference and/or dispute arises as to the amount of the expenses inc under sub-rule (2), the matter shall be determined by the Commission.
- 10. Avoidance of public nulsance, environmental damage and unnecessary date to the public and private property by such works: The licensee shall, while can out works, ensure that such works do not cause public nuisance, environmental dan and unnecessary damage to the public or private property.
- 11. Manner of deposit of amount for restoration of railways, tramways, waters etc;- The licensee shall deposit the amount for restoration of railways, tramwa waterways etc. under these rules by means of demand draft in favour of the officercharge of the maintenance of the works concerned.
- 12. Manner of restoration of property affected by such works and maintenant thereof:- The licensee shall carry out the restoration of property affected by works a undertake necessary maintenance thereof for one month.

- Getermination and payment of compensation to affected persons:- (1) Where the consec makes default in complying with any of the provisions of these rules, he shall take full compensation for any loss or damage incurred by reason thereof to the person flected, as may be determined by the District Magistrate or by any other officer attentions by the State Government in this behalf, if not agreed mutually between the arties concerned.
- Where any difference and/or dispute arises as to the amount of compensation elemined under sub-rule (1), the matter shall be determined by the Commission.
- 4. Procedure for deposit of compensation payable by the licensee and furnishing of curity:- (1) The amount of compensation payable by the licensee under these rules shall adoposited by means of demand draft.
- 2) The security required to be furnished under these rules shall be in the form of Bank Guarantee from a Scheduled Bank or in any other form as may be notified by the State Government from time to time.
- 5. <u>Determination of dispute and/or difference by the Commission</u>: When a matter shought to the Commission for determination under these rules, the matter shall be determined by the Commission within a period of thirty days and after hearing the parties oncemed.
- 6. Service of notice etc: Whenever a notice or intimation is required to be served upon person under these rules, the procedure provided under section 171 of the Act and rules made thereunder shall be followed.
