
- (1) APDISCOMs had PPA with the project which expired on 20.06.2015. The project has been acquired by APDISCOMs on 22.04.2016. APDISCOMs have submitted a proposal to GoAP for handing over this project to APGENCO. The approval from GoAP is awaited.
- (2) At present, APDISCOMs are procuring power from this project as short term purchase for the FY 18 based on the order passed by the Commission on 29.11.2017 in IA No.8 of 2017 in O.P.Nos. 28 & 29 of 2016. The plant is being operated by the employees deputed from APGENCO.
- (3) In the ARR for FY19, APDISCOMs have proposed to purchase power from this project. APDISCOMs have estimated the availability from the project at 784 MU, fixed cost at Rs.1.47/Kwhr and variable cost at Rs. 2.46/Kwhr (pass through based on gas price). The Fixed cost projections are made on the Capital Cost anticipating that the plant is taken over by APGENCO subject to the approval of GoAP.
- (4) Pending approval from GoAP to hand over this project to APGENCO, APDISCOMs pray the Hon'ble APERC to issue an order permitting



APDISCOMs to procure power from the project at an interim tariff with a fixed cost at Rs.0.79/Kwhr, which is the average Fixed Cost for the period from April-17 to Feb-18) and variable cost at Rs. 2.55/Kwhr, which is the based on the latest gas price (pass through based on gas price) during the first quarter of FY19.




